1. You can cancel this declaration at any time by notifying Helensburgh Heroes, Gift Aid will then not apply to donations you make on or after the date of cancellation, or such later date as you specify.
2. You must pay an amount of Income tax and/or Capital gains tax at least equal to the tax that Helensburgh Heroes reclaims on your donations/membership subscriptions in the appropriate tax year (currently 28p for each £1 you give)
